Terms of Admission

- (1) A non-refundable registration fee of \$100.00 is required with this application.
- (2) The non-refundable deposit and all post-dated instalments according to the Payment Schedule below must be included with this application.
- (3) Parents/guardians are responsible for the payment of all school fees for the year, regardless of decisions that result in the voluntary withdrawal of a child from the school for any reason. There is no refund or reduction in fees in case of voluntary withdrawal, absence, cancellation or non-attendance.
- (4) If your child has attended another program, you must sign a consent form for release of information pertaining to your child's previous educational experience. On the basis of the information obtained, Humbervale Montessori may request a meeting with the parents and/or student before confirming acceptance into our programme.
- (5) Humbervale Montessori School reserves the right in its sole discretion to accept or reject any application for admission or, notwithstanding the previous acceptance of an application, to later require the withdrawal of any child, if it is thought to be for the benefit of the student and/or class as a whole. A refund of only tuition fees on a prorated basis will be made in the event that the school requests the withdrawal of a child.
- (6) Children must be toilet trained. If your child is not toilet trained by August 1, then your child cannot attend school in September and a decision must be made at that time. If you feel that your child will not be ready for the current school year and you would like to wait until the following September, then the non-refundable deposit and the non-refundable first instalment only will be transferred towards tuition for the next school year. After August 1, parents have an unconditional obligation to pay fees charged for the full, upcoming school year. Please refer to the Parent Guide for more details.
- (7) A Toronto Public Health Medical Form must be completed for each child prior to attendance. This does not apply where the parents object to the immunization on the grounds that the immunization conflicts with their sincerely held convictions based on their religion or conscience beliefs, or if a legally qualified medical practitioner gives medical reasons in writing as to why the child should not be immunized. Objections and medical reasons shall be submitted on Toronto Public Health forms provided by HMS. The affidavit for personal reasons must be notarized.
- (8) This is a BINDING CONTRACT for the full 2019-2020 term: September 3, 2019 through June 12, 2020.
 - BE AWARE: All fees are due and payable in full upon our acceptance of your application. We will, however, accept post-dated cheques payable upon the dates below, in the amounts indicated. Staff requirements are determined based on enrolment before the commencement of the school year therefore, except as may be otherwise indicated, if your child leaves the program you remain liable for the fees, since we have no stand-by list of children/clients available to fill a place. FEES ARE NON-REFUNDABLE EXCEPT IN THE CASE OF DISMISSAL FROM THE PROGRAM; your post-dated cheques WILL BE negotiated except in the case of dismissal. In addition to any other remedies available to us at law, we will charge a \$25 service charge for any cheque returned NSF. A fee of 1% per month will be charged on all late tuition instalments.
- (9) Our school is a **NUT FREE ENVIRONMENT**. Please refer to the Parent Guide for details.
